The Principality of Liechtenstein forms a customs union with Switzerland. All cross-border deliveries of goods from the European Union are therefore subject to Swiss customs duty.


The border crossing of goods deliveries for Ospelt food AG must be coordinated with the Purchasing Department in Sargans. To do so, please contact Ms Diana Huhn (Email: diana.huhn@ospelt.com, Tel.: +41 58 377 31 72, Mob.: +41 79 519 19 84).

Crossing the border is not guaranteed if customs and procedural requirements are not observed. This may entail additional costs, if applicable, which are charged to the supplier.

3 Documents

3.1 Delivery note

- The delivery note accompanies the goods
- Order and Article Number Ospelt
- Number of pallets and their net weights
- Best-before date

3.2 Commercial invoice

- The commercial invoice accompanies the goods
- Please note the Ospelt order number on the commercial invoice
- The original commercial invoice must also be sent by post to the financial accounting department of Panetta SA.

3.3 Proof of preference

- The original proof of preference accompanies the goods.
- The following documents are acceptable as proof of preference:
- Movement certificate EUR.1
 - Declarations of origin on the invoice are only valid up to CHF 10,300 / EUR 6,000.
 - Approved exporters may always affix the origin declaration to the invoice.
 - Long-term delivery declarations are invalid in Switzerland and have no preferential character
- A preferential tariff treatment or exemption from customs duty can only be obtained by means of the proof issued by you at the time of customs clearance (physical border crossing).
- If the proof of preference is missing at the time of customs clearance, this results in considerable additional costs, which are charged to the supplier.
- Issuing incorrect proofs of preference results in criminal proceedings. The financial consequences of this are charged to the supplier.

3.4 Commercial documents / Veterinary documents

- The commercial document only applies to products from the EU
- Each consignment must be accompanied by a commercial document in accordance with Regulation EC 1069/2009.
- Further information is available at www.bvet.admin.ch
- It is the supplier's responsibility to ensure that all documents required, e.g. veterinary certificates, are available in the original at the time of the import declaration. The supplier is held liable for any risks of delay in delivery or resulting costs due to missing documents.



4 Customs clearance at the border

As the supplier, you prepare a commercial invoice, an export declaration and, if the regulations allow it, a proof of preference before the shipment. These documents accompany the goods in the original.

Please ensure that Swiss import customs clearance is only completed by one of the aforementioned customs agents. Our customs agents specialise in the customs clearance of our raw materials. Ideally, notify the customs agent 24 hours in advance of the arrival of the goods. This ensures smooth import customs clearance. Please note the opening hours of the Customs office selected.

Swiss Customs is entitled to order an inspection of the goods. You should therefore ensure that the goods specified correspond to the goods loaded on the vehicle. You are liable to prosecution if you make a false declaration to the Federal Customs Administration. This leads to criminal proceedings and further costs for you.

Please note that in Switzerland and Liechtenstein there is a night driving ban from 22.00 - 05.00 hrs.

5 Product protection

The supplier is to ensure that product protection for the goods being transported is guaranteed at all times.

It guarantees that the goods delivered are in perfect condition and are secured against intentional manipulation or falsification by third parties during transport. Appropriate agreements have been concluded with transport service providers, which are available to Panetta SA on request.

Deliveries of chilled and deep-frozen raw materials made of meat as well as raw materials in silo or tank vehicles or product-dependent special requirements for Panetta SA must be secured with seals on the semi-trailer or silo/tank vehicle (space closure). The seal number must be noted on the delivery document.

6.2.1 Food - Products, Sargans

The following pallets are accepted:

Plastic pallets 80x120cm

Europallets 80x120cm

Industrial pallets 100x120cm 4-sided accessible, wood quality III./IV. Class, 1000 kg load capacity

Chep (blue) 100x120cm

One-way pallets 80x120cm 4-sided accessible, wood quality III./IV. Class, 1000 kg load

capacity

The pallets must be suitable for high-bay storage and not have any overhang. The maximum weight is 1000 kg with a maximum height (incl. pallet) of 1.80 m.

When removing the transport protection and protective films, the internal transportability must be maintained, the palletisation must not disintegrate.



Each pallet must be labelled. The label must contain the following information:

- Net weight
- Batch number
- Supplier name
- Material name
- Material number Panetta
- Date of manufacture
- · Best-before date

When removing the transport protection and protective films, the internal transportability must be maintained, the palletisation must not disintegrate.

6.3 Unloading and pallet exchange, Sargans

Unloading the vehicle from the side is possible. Only trucks with a minimum height of 1.20m can be unloaded (no jumbos/no low-loaders).

The assessment of exchange suitability is effected based on the criteria analogous to EPAL. Pallet exchange takes place on delivery or otherwise by agreement. Pallets that are not exchangeable will be noted on the delivery note. One-way pallets are not exchanged.

Any Chep pallets delivered (blue) must be added to our Chep account. Please contact your responsible dispatcher for the initial booking of these pallets.

Non-compliance with the aforementioned pallet and packaging regulations may result in refusal of acceptance. The supplier is liable for any additional costs incurred as a result.

7.2 Pallet and packaging regulations, Weite

7.2.1 Fish products, Weite

Only Europallets (80x120cm) are accepted. Loose boxes without a pallet will not be accepted.

The maximum weight is 850 kg with a maximum height (incl. pallet) of 1.80 m.

When removing the transport protection and protective films, the internal transportability must be maintained, the palletisation must not disintegrate.

Each pallet must be labelled. The label must contain the following information:

- Net weight
- Batch number
- Supplier name
- Material name
- Material number Panetta
- Date of manufacture
- Best-before date

7.3 Unloading and pallet exchange, Weite

Unloading the vehicle from the side is possible. Only trucks with a minimum height of 1.20m can be unloaded (no jumbos/no low-loaders).

Pallet exchange takes place on delivery or otherwise by agreement. Pallets that are not exchangeable will be noted on the delivery note. One-way pallets are not exchanged.



8 Rejections

If acceptance of the goods is refused owing to defects, transport damage, etc., the goods must be returned via the customs office where the import customs clearance was completed.

The costs incurred are charged to the supplier.
